Tokom 2018. godine bio je angažovan u Kancelariji Visokog komesara Ujedinjenih nacija za ljudska prava u Ženevi, dok je 2019/2020. godine bio program menadžer u Ženevskom centru za upravljanje sektorom bezbednosti (DCAF), gde je vodio program podrške ombudsmanima, posebno u podsaharskoj Africi. Kao međunarodni ekspert pomaže jačanje institucija (parlamenta i nezavisnih kontrolnih organa) u različitim državama (Kamerun, Kenija, Niger, Liban, Ukrajina, Gruzija, Indonezija, Maldivi).

U fokusu njegovih aktuelnih istraživanja su nezavisni kontrolni organi, s posebnim akcentom na njihovo delovanje u slabim državama. Zainteresovan je i za pitanja demokratske civilne kontrole sektora bezbednosti. Objavio je tridesetak naučnih i stručnih radova, na srpskom i engleskom jeziku.
